

03	Who are eligible to apply	a) Retired Railway employees as mentioned above. b) Retired employees should not have been covered under Safety Related Retirement Scheme (SRRS) / Liberalized Active Retirement Scheme for Guaranteed Employment for Safety Staff (LARSGESS) c) Retired employees should not have been compulsorily retirement or removed or dismissed from service.
04	Medical fitness	Must be found medically fit in appropriate category.
05	Age limit / period of engagement	Must be within 65 years of age. The maximum age limit for re-engagement shall be 65 years of age and / or 01.12.2020 whichever is earlier. The limit shall not be exceeded during the period of engagement. Those re-engaged shall continue upto the last day of the month in which he/she attains the age of 65 years, i.e., following the same system as that of normal retirement.
06	Remuneration	The post to which the retired employee is re-engaged is not the criteria for fixing remuneration. Monthly remuneration to be governed by Rly.Bd.Letter.No.E(NG)II/2007/RC-4/CORE/1 dtd:24.10.2019 PCPO/MAS PBC.No.258/2019 dtd:12.11.2019.

**Procedure for re-engagement:**

Selection / Suitability and other conditions re-engagement	a) Suitability / Competency of the retired employee will be adjudged before re-engagement and the issue of their safety records as well as the safety and other operational requirements as needed, will be adequately scrutinised. The Selection is subject to the retired employees being found suitable by the Committee constituted for the purpose.
	b) Re-engaged retired employee will be discharged immediately, on joining the selected candidate from RRB/RRC or regular employees on transfer/ Promotion.
	c) The Administration is at liberty to terminate the service of the re-engaged personnel without prior notice, in case their performance is found to be unsatisfactory. The service of the re-engaged personnel will be terminated on attaining the age of 65 years or on joining the selected candidate from RRB/RRC or posting of regular employees on transfer/promotion or on whichever is earlier. The re-engaged employees will not have the right for continuity in service.

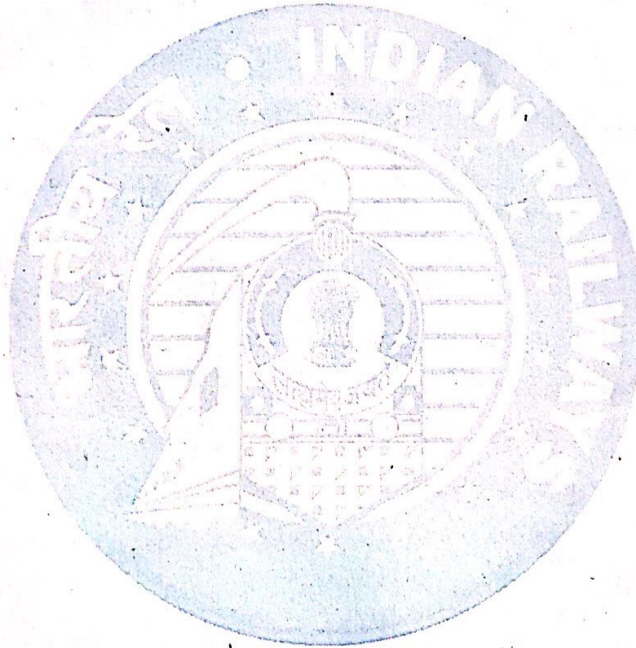
