Candidates are required to bring with them the following

- i) Filled in application as per the format at Annexure-I
- ii) Proof of Age (SSLC/SSC/Birth certificate/Indian passport)
- iii) Experience/service certificate from Tebma Shipyards
- iv) Last pay certificate or salary details of Tebma Shipyards
- v) Name of two references from Personnel of Tebma Shipyards

II. Period of Contract

All the posts above are for a **fixed term of five years**.

III. Remuneration

Salary shall be commensurate with qualification/experience. Candidates should bring the details of their last drawn pay in Tebma Shipyards (copies of salary slips/certificate etc.)

IV. Age

Age shall be relaxable at the discretion of TSL.

V. <u>Method of Selection</u>

- a) Candidates meeting the requirements shall attend a Walk in selection to be held from 23 Nov to 27 Nov 2020 (Registration from 0900 hrs to 1500 hrs) at Tebma Shipyards, Malpe.
- b) Candidates are requested to report for Walk in selection at the above venue within the stipulated time.

- The method of selection for the post shall be assessment of competencies through interview, test etc as decided by the selection committee.
- d) Depending on number of candidates, the assessment shall be scheduled on the same day or on next / later dates, as decided by the selection committee and informed to the candidates.

VI. Conditions

A. Experience:

- a) Candidates who are Ex-employees of Tebma Shipyards only need to appear for walk in selection and such candidates with experience specified for the post only will be considered.
- b) Candidates are requested to bring the experience/service certificate issued by TSL for verification of experience.

B. General:

- a) In the present context of Covid-19 pandemic situation, the candidates are informed to strictly abide by all safety and security instructions while at Tebma Shipyards for attending walk in selection and follow the instructions as listed under:-
 - (i) All candidates should strictly follow the guidelines for prevention of Covid-19 for attending the walk in selection.
 - (ii) It is advised to avoid crowding and to maintain social distance and practice hand hygiene. While using public transport make sure wearing personal protectives like mask, goggles, gloves etc. and avoid touching the surfaces using naked hands.
 - (iii) All candidates attending the walk in selection shall wear appropriate face masks properly covering their nose, mouth, chin etc. The candidates shall remove the mask at gates for identification. **THOSE CANDIDATES WITHOUT FACE MASKS SHALL NOT BE PERMITTED TO ATTEND SELECTION.**
 - (iv) All candidates seeking entry into the venue have to stand in the spaces marked at the Gates, entrances etc. so that social distancing of two meter can be ensured at these locations.
 - (v) NO CROWDING AT THE VENUE OR GATES FOR ENTRY/EXIT SHALL BE PERMITTED.
 - (vi) All candidates shall avoid touching any pillars, bars, hand rails etc with naked hands
 - (vii) All candidates should remove their jackets/overcoats etc at the gates for security check.
 - (viii) Compulsory screening shall be done for all candidates entering through gates with thermal scanner.

- (ix) Candidate who have fever and cough with breathing problems are advised not to attend the Walk in selection. Persons with these symptoms shall not come to Tebma Shipyards for the selection. Such candidates may inform the matter by email career@cochinshipyard.com.
- (x) All candidates shall bring their own water bottles / other refreshments and avoid sharing of personal items.
- (xi) All candidates shall bring their own stationery items and avoid sharing of such items.
- (xii) Movement to any other areas / buildings / work sites of Tebma Shipyards other than the venue of walk in selection shall be strictly prohibited.

b) Candidates are advised to make sure that they are meeting the experience requirements for the post.

- c) TSL reserves the right to call for any additional documentary proof from candidates in support of eligibility requirements. Queries if any should be obtained through the e-mail career@cochinshipyard.com However, Cochin Shipyard shall not be responsible for any delay/non-receipt of such e-mails within the stipulated date and time.
- d) No TA/DA shall be paid to the candidates for attending the selection.
- e) The vacancies are on contract basis for a specific period and TSL is not liable to offer appointment in the regular cadre during or after the completion of contract period of the selected candidates.
- f) Candidates should be of sound health and satisfy the medical fitness standards as fixed by the company. The candidates short-listed for appointment should undergo a medical examination in the hospitals as prescribed by TSL.
- g) No correspondence regarding the rejection of candidature in case of ineligibility, not having the required medical standards etc shall be entertained.
- h) The lists of experienced candidates shall be maintained for the posts and shall be operated only in the event of occurrence of a vacancy caused by non-joining of a candidate from the list OR, where a candidate joins the post and in the event of separation of a person from the post during the period of one year from the date of joining in TSL. The validity period of the list shall be upto one year or upto a date decided by TSL, unless a fresh notification for the same post is issued. Depending upon the increase in tempo of operations additional vacancies may also be sourced from among candidates who attend the walk in selection.
- i) Notwithstanding the above or any other conditions, TSL reserves the right not to fill up the vacancies notified. Further, the filling up of the notified vacancies shall be subject to the suitability of candidates and job requirements. CSL reserves the right to restrict/ alter/cancel/modify the recruitment process, if need so arises without notice or assigning any reason thereof.

- j) If at any stage it is found that any information furnished is false/ incorrect or the candidate does not satisfy the eligibility criteria, the candidature/appointment is liable to be cancelled/ rejected.
