This institute caters to the needs of five States such as Andhra Pradesh, Karnataka, Kerala, Tamil Nadu, Telangana and Puducherry Union Territory. The institute is an autonomous organization of the Ministry of Education, Govt. of India. From the academic year 2019-20,the Institute is offering Master's Program in Infrastructure Engineering and Management, affiliated to the Anna University, Chennai. The NITTTR Chennai is also declared as one of the National Resource Centres (NRC) in Civil and Environmental Engineering by the MHRD, Govt. of India. It is in the process of obtaining Deemed to be University status under UGC. NITTTR Chennai is identified as one of the "National Coordinators "under SWAYAM for the teacher education program; and Co-ordinator of AICTE – National Initiative of Technical Teachers Training
