- 4. The period of experience rendered by a candidate on part time basis, daily wages, visiting/guest faculty will not be counted while calculating the valid experience.

Reservation and Age relaxation

- 2. Since no post falls under reserved category, candidates belonging to reserved communities will not be entitled for any relaxed standard, including age. They will be treated on par with UR candidates, if they, otherwise, fulfill the requisite criteria.
