A. Vacancies:

### **B.** Eligibility Criteria:

The applicants should fulfil all of the following criteria to be eligible for appointment as a Yoga Teacher:

- (i) Only women are eligible to apply.
- (ii) Should possess a PG Diploma or MA in Yoga or equivalent.
- (iii) Should have Experience in Teaching Yoga (minimum one year).
- C. Period of Contract: Engagement will be on Contractual basis for ONE Year from the date of joining. The same is extendable on yearly basis at the discretion of the Management. Each term will be a fresh contract and at the end of each yearly term, contract will be deemed to have been expired. In case of extension, the extended term shall be treated as fresh contract of service and not as continuity.
- **D.** <u>Termination of the Contract:</u> The contract will stand terminated on completion of the prescribed tenure. The contract may also be terminated during the tenure with two months notice in writing by either side.

- 4. Short-listed candidates should produce all the relevant original certificates / testimonials along with one set of photocopies at the time of interview.
- 5. Depending on the requirement, the Company reserves the right to cancel/restrict the engagement process without any further notice and without assigning any reason thereof.
- 6. Incomplete / illegible / unsigned / multiple applications / applications not in the prescribed format or without photograph or those received after last date will be rejected.
- 7. While applying, the candidates are advised to ensure that they fulfill the eligibility criteria and other requirements mentioned in this advertisement and the particulars furnished by them are correct in all respect.
