- The Written test for the above position will be conducted through in- person at ICAR

 (https://sugarcane.icar@gov.in).
- 4. The candidates should bring a copy of bio-data(specimen enclosed), entire original certificates from SSLC onwards, one set of photocopies of certificates, experience certificate and latest passport size photograph at the time of written test.
- The candidate should atleast hold a Provisional certificate in r/o. Graduation/Post graduation/Professional courses.(website results/Awaiting for results candidates will not be considered).
- 6. No objection certificate from the employer, incase he / she is employed else where.
- 7. No TA/DA will be paid to any candidate to attend the Written test.
- 8. The above position is purely on temporary basis and is co-terminus with the project.
- There is no provision of re-employment after termination of project. The selected candidates will not have any right for claiming pay scale or absorption against any regular post being vacant on a later date at this Institute.
