^{*}The qualification prescribed shall be from a recognized University/ institute as a full time regular course in relevant discipline. Qualification acquired through part time/ correspondence/ distance learning mode shall render the candidate ineligible.

- Age limit:- The minimum age limit is 18 years and maximum age limit is 30 years as on closing date i.e 15.07.2021 (Relaxation of 05 years for SC/ ST and 03 years for OBC (Non creamy layer) and 10 years for PWDs).
- 3. **Period of Apprenticeship Training**:- The period of apprenticeship training will be for a period of one year
- 4. **Reservation**:- Reservation for SC, ST, OBC (Non-creamy) and EWS will be as per the provision of the Apprenticeship Act 1961 and the rules framed thereunder as amended till date.
- 5. Candidates who have completed three years after acquiring the prescribed education qualification as on date of reckoning i.e 15.07.2021 shall not be eligible for engagement.
- 6. Preference will be given as under:
 - a. First preferences will be given to Project affected families.
 - b. Second preference will be given to candidates of Leh District.
 - c. Candidates of other districts of Ladakh will be given third preference.
