INSTRUCTIONS

1) Requiring the candidates to attend oral test, provisionally, will not confer any right on them for appointment.

2) The candidates are strictly instructed to bring the following, without fail:-

(A) All the original certificates in proof of their educational and technical Qualification claims made in their online application, along with self attested copies of the same, for verification. Candidates, without original certificates and self attested copies, will not be permitted for oral test.

(B) Hall Ticket for Oral Test along with any one photo ID, like Driving License, Pan Card, Voter ID, Aadhar Card, etc., in original and necessary Certificates viz., (i) Conduct and Character Certificates obtained from two persons (ii) No Objection Certificate from Employer, if necessary and (iii) Experience Certificate if available as prescribed in **Annexures – 'A', 'B' and 'C' of the Instructions to Candidates.**

[The candidates who claimed reservation in their online application under PH/PSTM and claimed Fee Exemption under respective Communities/PH/DW/shall submit their respective certificates. Otherwise, they will not be allowed for oral test].

(C) With regard to the candidates, who claimed reservation under PSTM, They shall submit PSTM certificates in proof of their study in Tamil Medium in the prescribed format from Std I to U.G. Degree. Otherwise, they will not be considered under PSTM category

3) Any request for change of date, time or venue will not be entertained, under any circumstances.

4) <u>DRESS CODE</u> : THE CANDIDATES MUST BE FORMALLY ATTIRED WHILE ATTENDING THE INTERVIEW. THE MALE CANDIDATES SHALL WEAR FORMAL FULL HAND SHIRT AND PANT AND THE FEMALE CANDIDATES SHALL WEAR SAREE/SALWAR KAMEEZ / CHURIDAR. THE CANDIDATES WHO DO NOT ADHERE TO THE SAID DRESS CODE, WILL NOT BE PERMITTED FOR ORAL TEST.

5) THE CANDIDATES SHALL SUBMIT COVID-19 NEGATIVE CERTIFICATE, TAKEN 48 HOURS BEFORE THE DATE OF THEIR RESPECTIVE ORAL TEST. THE CANDIDATES WHO ARE NOT SUBMITTING THE SAID CERTIFICATE WILL NOT BE PERMITTED FOR ORAL TEST.

6) The candidates shall always wear mask and they will not be permitted into the venue without wearing mask. While entering the venue, the candidates shall sanitize their hands and undergo thermal scanning for temperature.
