4. The candidates should bring a copy of bio-data(specimen enclosed), entire original certificates from SSLC onwards, one set of photocopies of certificates, experience certificate and latest passport size photograph at the time of interview.
5. **The candidate selected for written test should bring 'RT-PCR' test report and produce at the time of certificate verification.**
6. The candidate should atleast hold a Provisional certificate in r/o. Graduation/Post graduation/Professional courses.(website results/Awaiting for results candidates will not be considered).
7. No objection certificate from the employer, incase he / she is employed else where.
8. No TA/DA will be paid to any candidate to attend the Written test cum interview.
