ELIGIBILITY REQUIREMENTS

- 1. Case Worker: Any woman having a Law degree/ Masters in Social Work with at least 3 years experience of working on violence against women issues in a Government or Non-Government project/programme.
- 2. Women Police Officer: Retired Police Officer preferably a woman police officer at the Sub-Inspector level, with experience of working for at least 5 years in the field of women issues, preferably All Women Police Station puducherry.
- 3. Counselor Any woman having a postgraduate degree in Social Work/ Clinical Psychology with at least 3 years of experience of working as Counsellor / Psychotherapist in a reputed Mental Health Institute/Clinic at the District/State level.
- **4. Para Legal Staff:** Any person having a background in Law/ Social Sciences with para legal training or knowledge of laws with at least 3 years' experience of working within a Government or Non-Government project/programme on Violence Against Women at the district.
- **5.** Para Medical Staff Any woman having professional degree in paramedics with a background in health right and preferably with at least 3 years' experience of working within a Government or Non-Government health project / programme on Violence Against Women at the district.

Mode of awarding weightage of marks.

- The applications will be invited through advertisement and the merit list will be prepared on the basis of following guidelines:
- The weightage for percentage /Grade for possessing the required UG/PG qualification will be calculated as follows:
 - -Below 50% or 'E' grade minus 5 marks
 - Below 70% or 'D' grade minus 3 marks
 - Below 80% or 'C' grade minus 2 marks
- The Master/Bachelor Degree course should have been completed within the prescribed duration of course.
- 1 marks will be deducted for every additional attempt, It is applicable for both semester and non-semester system.
- 5 marks will be deducted for completing the course on the next year after the
 qualifying degree course period and 10 marks will be deducted for completing
 the course after two years of the qualifying degree course period and so on.
- After arriving the qualifying marks in the respective Degree courses, if there is
 a Tie of marks among the applicants, the merit list based on consideration of
 their Date of Birth (i.e. Senior in Age will be considered as first) shall be
 followed.
- If there is any gradation in the marks of the bachelor degree of concerned subject, it should be referred to Directorate of Higher and Technical Education, Puducherry for its equivalent marks of that concerned subject of Degree before arriving the qualifying marks for preparation of merit list.
- After evaluation of marks, the candidates will be filtered based on the weightage of marks and written exam will be conducted.

Terms and Conditions for Candidates:

- The positions are purely temporary, time bound and co-terminus with the scheme or earlier depending on the performance.
- The appointment will be terminated either with the termination of the scheme or even before at the discretion of the competent authority.
