ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENT (1 YEAR TENURE UNDER CONSOLIDATED REMUNERATION)

Upper age limits will be 45* years as on date of interview.

- (i) MBBS and MD/MS/DNB Degree from MCI/NMC recognized Medical College / Institution.
- (ii) Qualification and Experience as per "Teachers Eligibility Qualifications in Medical Institutions, 2022 read with MSR 2023" as amended and applicable as on date to the respective posts.
- (iii) Should have registered with MCI/NMC or State Medical Council.
- *Relaxation for SC/ST/OBC/PH/Ex-SM candidates will be applicable as per Government Rules.

Emoluments for The Post of Senior Resident (1 year tenure under consolidated remuneration)

For Senior Resident (1 year tenure under consolidated remuneration) - Rs. 1,40,140/- (Consolidated remuneration) per month. In addition to the pay above, the Senior Resident will be entitled for transport allowance with DA on transport allowance as per rules. DA on transport allowance will be revised from time to time as per rules.

The consolidated remuneration will be revised whenever there is revision of rates of DA as per ESIC Hqrs. Office Memorandum no. Z-17/11/1/2007/Med.IV (Pt.file) dated 13.04.2022.

General Terms & Conditions for Senior Resident (1 year tenure under consolidated remuneration)

- a) The engagement will be for a period of **one year** or till regular incumbent joins, whichever is earlier under consolidated remuneration.
- b) The Senior Resident (1 year tenure under consolidated remuneration) is entitled for leave as per the Contractual Labour [Regulation & Abolition Act] 1970.
- c) Private practice of any kind will not be allowed.
- d) Rules for Reservation will be implemented as per Govt. of India instructions.
- e) The engagement shall not confer any right or preference for regular appointment.
- f) No claim for any service benefits like PF, Pension, Gratuity, Medical allowances, Medical benefits, Seniority, Promotion etc. will be admissible.
- g) Candidate must be registered with State Medical Council/Medical Council of India/ NMC as applicable, before joining the post.
